ORDINANCE NO. I-3

AN ORDINANCE READOPTING THE EXISTING CHICKASAW COUNTY CODE OF ORDINANCES

WHEREAS, *Iowa Code* section 331.302(10) requires that at least once every five years the Chickasaw County Board of Supervisors shall compile a Code of Ordinances containing all of the existing county ordinances in effect; and

WHEREAS, the Chickasaw County Board of Supervisors has complied a Code of Ordinances containing all of the existing ordinances in effect in Chickasaw County; and

WHEREAS, the Chickasaw County Board of Supervisors has determined that the proposed Code of Ordinances should be readopted.

NOW, THEREFORE, THE FOLLOWING ORDINANCE READOPTING THE EXISTING CHICKASAW COUNTY CODE OF ORDINANCES IS HEREBY ENACTED:

SECTION 1. PURPOSE

Iowa Code section 331.302(10) requires that at least once every five years the Chickasaw County Board of Supervisors shall compile a Code of Ordinances containing all of the existing county ordinances in effect. The Chickasaw County Board of Supervisors has complied a Code of Ordinances containing all of the existing ordinances in effect in Chickasaw County. This ordinance readopts the existing Code of Ordinances now in effect.
