Black Hawk County Public Health

Sarah informed the board that Black Hawk County is applying for a grant. This grant will be used to prevent, test, and care for those with Communicable Diseases like hepatitis and HIV/Aids. The grant amount is \$125,000. Black Hawk County hopes to collaborate with Chickasaw County to provide services to county residents. A motion by Knoll, seconded by Shoemaker to approve partnering with the Black Hawk County Syndemic Prevention Outreach and Testing Services (SPOTS) Program. All Ayes. Motion carried.

The agency activities for August 2024 were presented by Lisa. Derek completed 5 septic site evaluations, 6 septic site finals, 1 binding agreement, 2 well plugging, 1 shock chlorination, and 32 water tests.
