White Avenue and located entirely within the city limits of the city of Alta Vista; WHEREAS, the city has advised the county that the parcel has been abandoned and presents a public nuisance and the city has agreed to take action to remediate the public nuisance; WHEREAS, Chickasaw County may assign a Tax Sale Certificate to another entity; and WHEREAS, Chickasaw County has the right to abate past due property taxes. NOW, THEREFORE, BE IT RESOLVED that pursuant to *Iowa Code* section 446.31(2) Chickasaw County does hereby assign Tax Sale Certificate No. 15-0063 for Parcel No. 190329201024 to the city of Alta Vista. The treasurer shall collect from the assignee an assignment transaction fee of ten dollars to be deposited in the county general fund. IT IS FURTHER RESOLVED that upon the city of Alta Vista providing proof of a valid tax sale deed to the Chickasaw County Treasurer, Chickasaw County does hereby abate in full all of the past due property taxes for this parcel as well as any and all fees and penalties. IT IS FURTHER RESOLVED that Resolution No. 12-09-24-50 is rescinded and replaced.
