

**CHICKASAW COUNTY
BOARD OF SUPERVISORS' MINUTES
January 2, 2026**

The Board convened on Friday, January 2, 2026, at 9:03 AM with members Breitbach, Suckow, Carter, Cerwinski and Hackman present in the Boardroom on the second floor of the Court House, New Hampton, Iowa. Chairperson Hackman called the meeting to order. Also present were Board Secretary Sheila Shekleton, Bob Fenske, member of media, and Sheriff Ryan Shawver.

Motion by Cerwinski, seconded by Suckow to approve RESOLUTION NO. 01-02-26-01 PRIOR PAYMENT OF BILLS, WHEREAS, at certain times it is necessary to pay bills prior to an official Board of Supervisors meeting in order to allow for the efficient operation of county government. BE IT HEREBY RESOLVED by the Board of Supervisors of Chickasaw County, Iowa, that the County Auditor is authorized to issue warrants when said Board is not in session for the following purposes provided for in Iowa Code Section 331.506(3) and that all bills paid pursuant to this resolution shall be reviewed by the Board of Supervisors at the first meeting following such payments. 1. For the fixed charges including, but not limited to, freight, express, postage, utilities, telephone service or contractual services previously approved by the Board of Supervisors, after a bill is filed with the Auditor. 2. For salaries, payrolls and payroll taxes if the compensation has been fixed or approved by the Board of Supervisors, under whose direction or supervision the compensation is earned. Motion by Cerwinski, seconded by Breitbach to approve RESOLUTION # 01-02-26-02 CONSTRUCTION EVALUATION RESOLUTION WHEREAS, Iowa Code section 459.304(3) sets out the procedure if a board of supervisors wishes to adopt a "construction evaluation resolution" relating to the construction of a confinement feeding operation structure; and WHEREAS, only counties that have adopted a construction evaluation resolution can submit to the Department of Natural Resources (DNR) an adopted recommendation to approve or disapprove a construction permit application regarding a proposed confinement feeding operation structure; and WHEREAS, only counties that have adopted a construction evaluation resolution and submitted an adopted recommendation may contest the DNR's decision regarding a specific application; and WHEREAS, by adopting a construction evaluation resolution the board of supervisors agrees to evaluate every construction permit application for a proposed confinement feeding operation structure received by the board of supervisors between February 1, 2026 and January 31, 2027 and submit an adopted recommendation regarding that application to the DNR; and WHEREAS, the board of supervisors must conduct an evaluation of every construction permit application using the master matrix created in Iowa Code section 459.305, but the board's recommendation to the DNR may be based on the final score on the master matrix or may be based on reasons other than the final score on the master matrix; NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF CHICKASAW COUNTY that the Board of Supervisors hereby adopts this construction evaluation resolution pursuant to Iowa Code section 459.304(3). Motion by Cerwinski, seconded by Breitbach to appoint Roman Lensing as County Engineer. Roll Call: All Ayes. Motion carried.

Motion by Suckow, seconded by Breitbach to appoint Keith Elenz as Veterans Affairs Administrator. Roll Call: All Ayes. Motion carried.

Motion by Suckow, seconded by Cerwinski to place the Eminent Domain Compensation Commission list on file at the Chickasaw County Auditor's Office and letters will be sent to appointed residents. Roll Call: Ayes Suckow, Cerwinski, Breitbach, Hackman. Abstained: Carter Motion carried.

Motion by Breitbach, seconded by Carter to appoint Chad Humpal as Weed Commissioner. Roll Call: All Ayes. Motion carried.
