ATV-UTV OPERATION STATE PARK ROAD SYSTEMS

SECTION 321I.10(2A) NEW SUBSECTION

Ref. House File 2237 Effective 7-1-24

A registered all-terrain vehicle or off-road utility vehicle may be operated on state park road systems, and may be operated anywhere within the boundaries of a state park that a motor vehicle required to be registered under chapter 321 is authorized to operate.

The Conservation Board will follow the new code section that allows <u>registered all-terrain vehicle or off-road utility vehicle in state parks</u>. The board also wants to point out that the code states <u>and may be operated anywhere within the boundaries of a state park</u> <u>that a motor vehicle required to be registered under chapter 321 is authorized to operate</u>. This is understood to be roads/drives and parking lots that regular vehicles are allowed to operate. It does not give permission to go off-roading in any areas. Creature Feature by Matt Crayne, Naturalist

Striped Skunk Mephitis mephitis

The scientific name of the striped skunk is Latin for 'bad odor'. I don't know about you, but I don't mind the smell of a skunk, as long as it's not too close! I remember being a young man and liking the smell and taste of a certain skunky beverage made in Holland. And fortunately, I've never been sprayed by a skunk. I suppose that makes it a bit easier to not mind the smell. I'm sure that those of you with dogs that don't mind tangling with skunks probably have a different opinion!

The striped skunk does its best to let those dogs, as well as people, know that you should leave them alone. I mean a black body with white striping should be a pretty good indicator right? The striping starts with a thin white line behind the nose. It widens greatly on the back of the head

and then splits around the shoulders. The coloration can vary individually. If you see a skunk turn its back end towards you and lift its tail, it is time for you to leave the immediate area, and quickly!

The skunk is a medium sized mammal with a thick body and short legs. They have 5 clawed toes on each foot (with longer claws on the front feet). They are about 20-30 inches in length and can weigh up to about 12 pounds. Similar to many other mammals, the male skunk tends to be larger than the female skunk.

The lifespan of a striped skunk is not particularly long. In the wild, they usually don't live more than 2 or 3 years. This means that in most cases, the wild population has been replaced in a 5 year span. They have been known to live up to 10 years in cap-



tivity. Overall, the striped skunk is considered a nocturnal animal, even though it can be seen foraging during the daylight hours.

Striped skunks can be found throughout the continental United States, most of the southern 1/2 of Canada, and in Northern Mexico. They are adaptable to a number of habitats, bet prefer woodland edges, thick and brushy areas, fencerows, grasslands and ravines. They do require a permanent source of water nearby. They will den underground or in an old stump, hollow log, brush pile, etc. They will also use burrows left behind from other animals such as woodchucks. These dens need to reach below the frostline for winter. They will insulate a chamber with leaves and/or grasses, depending on what's available, and may plug openings for the winter as needed.

Striped skunks breed in the late winter to early spring. Gestation is about 2 - 2 and 1/2 months, and they will have litters of around 4-8 young who will stay with the female until fall.
