WHEREAS, ALL OF THAT PART OF THE ROADWAY RIGHT-OF-WAY EASEMENT IDENTIFIED AS THE WEST ONE-HALF OF THE VACATED STREET LYING EAST OF AND ADJACENT TO LOT 28 AND THE SOUTH ONE-HALF OF THE VACATED STREET LYING NORTH OF AND ADJACENT TO LOTS 24 AND 29 OF THE IRREGULAR SURVEY OF THE SOUTHEAST QUARTER (SE ¼) OF SECTION 28, TOWNSHIP 95 NORTH, RANGE 12 WEST OF THE 5<sup>th</sup> P.M. IN CHICKASAW COUNTY, IOWA, is no longer of value to the citizens of Chickasaw County, Iowa; and

WHEREAS, it is in the best interests of the citizens of Chickasaw County, Iowa, that the roadway right-of-way easement be abandoned and revert to the owner of the adjacent real property given there is a resolution abandoning the street dated September 6, 1977; and

WHEREAS, Lennie H. Drewelow and William J. Drewelow are the owners of the adjacent real property; and

WHEREAS, *Iowa Code* section 306.11 authorizes the Chickasaw County Board of Supervisors to abandon a roadway right-of-way easement reversion that will not change the existing traveled portion of the roadway or deny access to any roadway by adjoining landowners without conducting a hearing and merely by resolution; and

WHEREAS, the Chairman of the Board of Supervisors of Chickasaw County, Iowa, and the Chickasaw County, Iowa, Auditor shall be authorized to sign a quit claim deed transferring any and all ownership interest in the roadway right-of-way easement to Lennie H. Drewelow and William J. Drewelow as the owners of the adjacent real property.
