RESOLUTION APPROVING AND AUTHORIZING EXECUTION OF JOINT AGREEMENTS BETWEEN CHICKASAW COUNTY, IOWA AND VARIOUS CITIES RELATED TO THE INCLUSION OF LAND WITHIN EACH CITY'S "AREA OF OPERATION" WITHIN THE PROPOSED CHICKASAW COUNTY CWEC URBAN RENEWAL AREA

WHEREAS, Chickasaw County, Iowa (the "County") has caused a proposed urban renewal plan to be known as the CWEC Urban Renewal Plan (the "Urban Renewal Plan" or "Plan") to be prepared, the purpose of which Plan is to establish the proposed CWEC Urban Renewal Area (the "Urban Renewal Area") described therein; and

WHEREAS, the Urban Renewal Area is proposed to include property that is within the corporate boundaries of, or within two miles of the corporate boundaries of, the City of Alta Vista, the City of Bassett, the City of Elma, the City of Fredericksburg, the City of Ionia, the City of Lawler, the City of New Hampton, the City of North Washington, and the City of Protivin (the "Cities"), and accordingly the Urban Renewal Area would include land within the "area of operation" of these Cities (as defined in Iowa Code Section 403.17(4)); and

WHEREAS, Iowa law requires a county to obtain consent from the governing body of a city before including land within the city's "area of operation" in an urban renewal area, which consent should be documented in the form of a joint agreement executed between the county and the city; and

WHEREAS, in order to proceed with the proposed Urban Renewal Area, this Board desires to approve joint agreements with the Cities and seek consent from the governing body of each of the Cities to the respective joint agreement.

NOW THEREFORE, BE IT RESOLVED, BY THE BOARD OF SUPERVISORS OF CHICKASAW COUNTY IN THE STATE OF IOWA:

Section 1. That the County Assessor, other members of the County's TIF Committee, and other County officers and representatives are hereby directed and authorized to contact the City of Alta Vista, the City of Bassett, the City of Elma, the City of Fredericksburg, the City of Ionia, the City of Lawler, the City of New Hampton, the City of North Washington, and the City of Protivin, requesting that the governing body of each city approve a joint agreement with the County with respect to inclusion of property within the city's "area of operation" in Chickasaw County's proposed CWEC Urban Renewal Area.

Section 2. That the form and content of the joint agreements with the City of Alta Vista, the City of Bassett, the City of Elma, the City of Fredericksburg, the City of Ionia, the City of Lawler, the City of New Hampton, the City of North Washington, and the City of Protivin, respectively, each in the form presented to the Board with this Resolution, are hereby approved; furthermore, the Chairperson and the County Auditor are hereby authorized, empowered and
