### Monument Description and Remarks:

SE Cor SW $\frac{1}{4}$  SW $\frac{1}{4}$ -History of Corner

No available record indicates that this corner was ever monumented.

Corner Recovery- Searched 4.0' area around a point equidistance between SW Cor and S $\frac{1}{4}$  Cor with metal detector and found nothing. Since no monument can be located, set 'Survey Mark' nail flush in ACC at point equidistance between SW Cor and S $\frac{1}{4}$  Cor (see plat filed with this corner certificate for measurements) and used it as the correct corner. Nail is 6.8' N of centerline joint of ACC road E-W and 7.0' W of fenceline N. All ties are plumb distance unless indicated otherwise.

This certificate is being prepared because there are no certificates on file for this corner and this corner was used for a survey in this section for Evelyn G. Thompson.




