MONUMENT DESCRIPTION AND REMARKS:


NORTHEAST CORNER: Westwood Professional Services found a survey nail with IDOT washer, 1 tie per 1922 tie book and 2016 corner record, and 4 ties of unknown origin. Accepting corner location. Filing corner record as there are changes to the reference ties of record.

SOUTHWEST CORNER: Westwood Professional Services found a 1/2" square twisted bar 0.8" deep, 2 ties from 2001 record and 1 tie of unknown origin. Accepting corner location. Filing corner record as there are no longer 3 valid ties of record.

SOUTH QUARTER: Westwood Professional Services found a 5/8" rebar with aluminum cap LS11442 0.4" deep and 1 tie of previous record. Accepting corner location and set 2 ties. Filing corner record as there are no longer 3 valid ties of record.
